

MCCC MEN'S WRESTLING OPERATING CODE

I. Organization of Coaches Group and Meetings

A. Membership

1. All wrestling coaches of the MCCC may participate.
2. Each member college will have one vote.

B. Chair and Secretary

1. The coach of the tournament host college will serve as President and Chair meetings.
2. The secretary will keep written records of all business conducted. These records will be sent to the membership and the MCCC Coordinator as an addendum to the minutes.

C. Coaches Meetings

1. Regular annual meetings will be scheduled at the state tournament. Meeting date and time will be called by the tournament host.

II. Competitive Season

A. Scheduling: The first scheduled meet may not be earlier than 2<sup>nd</sup> Friday preceding Thanksgiving.

B. Practice starting date shall be October 15 of each year.

III. Rules and Regulations

A. Scheduling

1. All teams shall wrestle the other teams twice, home and home.
2. All meets are to be completed before the MCCC tournament.
3. When two MCCC colleges wrestle in the same triple dual, they shall wrestle each other first, before any other competition - unless the two coaches mutually agree to wrestle later.
4. The MCCC will follow the NCAA rulebook for all dual meet ties.

B. Special Rules

1. Weigh-in for dual meets shall be conducted at host school site, one hour prior to match time.
2. Standard weigh-in sheets shall be used. NJCAA weigh-in policies will be followed.

IV. Division Organization: Wrestling is structured into one Division.

V. Eligibility & Rules

- A. NCAA rules shall be used in season and state meet competition.
- B. NJCAA rules shall govern competition.

VI. Awards Procedure

- A. A Division team champion trophy shall be awarded based on dual meet competition.
- B. The coach of the State Championship team will be named MCCC Coach of the Year.

VII. State Meet Policies

## A. Date-Location

- 1. Effective in February 2004, the MCCC Tournament will be held in conjunction with North Central District (Region 13 & 11). The host rotation schedule is listed below. The 2006 tournament date is Sunday, February 12, 2006.

  - 5. Rochester 2010
  - 6. Iowa Central 2011
  - 7. Itasca 2012
- 2. If a college declines the MCCC rotation, the next college will have the opportunity.
  - 3. The coaches meeting will be held at 8:00 PM the night preceding the tournament. The seeding meeting will take place at 10:00 AM the day of the event, weigh-ins at 11:00 AM, and wrestling to start at 1:00 PM.
  - 4. Weigh-in will be two hours prior wrestling.
  - 5. In the event a college has accepted hosting the wrestling state and Region XIII tournament, and should there be a conflict with a "home" basketball game, the "home" basketball team may need to travel to the visiting site to play the schedule basketball game.

## B. Meet Regulations

- 1. Each team is allowed to enter one participant in each weight classification.
- 2. In the event that any participants arrive too late to make the weigh-in deadline, they may still participate in the tournament if it is determined that:
  - a. The late arrival was unavoidable.
  - b. No wrestlers gained an actual advantage by arriving late.
  - c. Their participation will not delay the tournament. Such a determination will be made only if a favorable note is cast by at least a majority of the wrestling coaches in the tournament.

## D. Tournament Expenses

- 1. This is a combined MCCC and Region XIII tournament! There is a \$50 Region entry fee from each team to help defray costs of supplies.

E. Tournament Seeding Guidelines

General Rules:

1. Seeding shall be done by the coaches:
2. Each coach shall provide accurate written information.
3. Criteria for Seeding:
  - a. Head to head competition (Any official match.)
  - b. Common opponents
4. Points to be considered.
  - a. Overall record
  - b. National place winner
  - c. Regional place winner
5. Seeding Procedures
  - a. Coach allowed 2 minutes to state argument/point.
  - b. Coach may ask for review of one if error suspected.
  - c. Coach allowed 2 minutes to explain rationale.
  - d. Additional information accepted from other coaches.
  - e. Coaches vote - majority rules - in case of tie, flip of coin.
